Thank you for inquiring about a loan with Canals-Trails Credit Union. Below is a list of the Information that we will need to begin processing your loan application:

For all loans:

- Completed loan application, including rent or mortgage payment amount, signed, and dated by all applicants
- Proof of all income including 2 most recent paycheck stubs
- \$25.00 non-refundable loan application fee

In addition for collateral loans:

- A description of the collateral to be used to secure the loan, including VIN#, and mileage for vehicle loans
- A bill of sale, whether purchasing from a dealership, or a private party
- If refinancing, contract from dealership, 10 day payoff, loan#, \$95.00 transfer title fee, and name and address where to send payoff

Loan rates will be determined by applicant's credit score. A score of 560 or above is required For single applicants, 600 or above for joint applicants. Final loan approval will be based on Credit score and debt ratio.

The average time frame for loan processing once we have all required information is 1-2 days, Depending on loan volume. Please call Bob or Patty to check the status of your application.
